# Trafford Council

Homelessness Strategy 2025-2030 Summary Statement









#### Introduction

Under the Homelessness Act 2002, it is a legal requirement for Local Housing Authorities to publish a new Homelessness Strategy every five years, after completing a review into homelessness within the borough.

In line with the legislation, the Trafford Homelessness Strategy 2025-2030 sets out the priorities for tackling homelessness in the borough over the next 5 years. The findings of the homelessness review have been used to shape the Strategy, which outlines the main causes of, and provides a strategic plan to tackle, homelessness and rough sleeping in Trafford.

This statement will provide a summary of the Trafford Homelessness Strategy 2025-2030.

#### Vision

The Trafford Homelessness Strategy 2025–2030 vision is:

"Work together to prevent homelessness and eradicate rough sleeping in Trafford"

## **Strategic Priorities**

Following a review of policy and strategic context, homelessness in Trafford, and an analysis of internal and external data, the following strategic priorities have been identified:

- 1. Prevent homelessness in Trafford
- 2. Increase the supply of good quality temporary accommodation and reduce the use of Bed and Breakfast/emergency hotel accommodation.
- 3. Ensure Trafford residents can access suitable and affordable settled move-on accommodation.
- 4. Support residents to maintain their tenancies to avoid repeat homelessness.
- 5. Work towards eradicating rough sleeping in Trafford.

Each Strategic Priority has several key recommendations which the Council and its partners must deliver to achieve the overall vision of the Strategy. These recommendations are listed at the end of the Summary Statement and will be used to create an Action Plan to facilitate the delivery of the Homelessness Strategy.

### **Delivery of the Strategy**

The strategic priorities and recommendations will be delivered through the Homelessness Strategy 2025-2030 Action Plan.

This strategy cannot be delivered by the Council working in isolation; achievement will require collaborative working with public sector organisations at local and national level, alongside private and voluntary sector partners.

The Action Plan has been developed in partnership with stakeholders, partners and agencies and agreed by the Homelessness Champions Group (HCG). It will provide detailed actions and targets to ensure that we achieve the priorities identified over the next five years by 2030. The Action Plan will be reviewed annually to ensure that all new changes in legislation and policies/strategies developed by the Council are reflected.

An annual statement will be published each year to show progress against the various objectives contained within this Strategy.
